## Town of Edgecomb Select Board Minutes February 25, 2019; 6:00pm

- 1. Pledge of Allegiance
- 2. Approval of Minutes
  - a. 2/11/19 minutes approved 3-0.
- 3. Fred Brewer, Auditor
  - a. Discussion of budgeted expenses and what was spent what should go into surplus?
  - b. Mike asked if it would be possible to adopt a "storm fund" Fred said that it is up to the board and fiscally responsible. Fred said the easiest way would be to let the money from FEMA go into surplus and then redefine a new fund.
  - c. Prior to things voted to be taken out of surplus there is \$602,990.58 in undesignated fund. This is 1.8 months of expenses in undesignated fund should have 2-3 months as a rule of thumb. This is an improvement over a few years ago.
- 4. Old Business
  - a. Appointment of Assistant Harbor Master, Kris Niederlitz
    - i. Approved 3-0.
    - ii. The assistant harbor master will be paid \$500. Corning also suggested that new (initial) mooring fee should cost \$100 for residents and non-residents it should be \$300. Commercial moorings would be half the cost. Corning prepared new mooring applications. Corning also mentioned the change in the waterfront ordinance and that they would need legal help writing the ordinance. Corning mentioned that if there were recurring mooring fees it would be difficult to enforce. Jack would like to explore how other towns handle the mooring fees. Corning would like to change the structure of the waterfront committee, perhaps to have the Harbor Master and Deputy harbor master to be non-voting members of the town meeting. \*\*This will need to be discussed again prior to town meeting as an item.

    - i. Not yet available.
